1. Purpose and Reason

This policy is for the website streemin.co.uk (alternately referred to as streemin) and its derivatives. Here at streemin we take your privacy seriously and will only use your personal information to administer your account and to provide the services you have requested from us. This policy sets out the different areas where your privacy is concerned and what data we collect, if any. Furthermore, the way this website processes, stores and protects user data and information will also be detailed within this policy.

2. Data Collected by Us

In addition to content and material that you supply to, or is disseminated through the website, we collect and store any data that you voluntarily provide on the registration form of the website and through your account profile, as well as your IP address, which is collected automatically. The following data is collected through your account:

Your email address, your year of birth, your gender, a preferred username, a preferred personal profile description.

Only a preferred username, email address and password are required to create an account on streemin. Other information is entirely voluntary and optional.

We use cookies across the website, which are tiny text files saved in your browser, to provide the best possible user experience. Please refer to the streemin cookie policy for more information on our use of cookies. We also make use of third-party suppliers who may use tracking methods such as cookies to track your browsing habits. Data collected through these means is anonymous and is not linked to you personally.

3. How We May Contact You

From time to time we would like to contact you with details of offers, services and competitions that we provide. We may also need to contact you about your account. We will only attempt to contact you by email. By maintaining a streemin account, you explicitly provide your consent for us to contact you by these means. If you do not

consent to us using your email address to contact you, you may request that we delete your account at any time. To comply with EU legislation, this must be done in writing. Please forward your account cancellation request to the following address:

4. Data Storage and Lifespan

Data is stored digitally on the systems maintained by our web hosting provider. We only keep data as long as is necessary to provide the website services and/or for statistical analysis. You may request, at any time, that we remove any data we have on record that is personally identifiable to you, or linked to you personally. We reserve the right to delete your streemin account entirely in response to any such request.

5. Age Restriction and Parental Control

It is not the policy of streemin to collect data from minors or specifically any child under the age of 16. Children under the age of 16 are not permitted to register with streemin. By using the website, you affirm that you are over the age of 16. Having the permission of a parent or legal guardian does not permit you to use the website if you are under the age of 16. The website and its content is not intended for audiences younger than 16 years of age.

If you are aware of a child under the age of 16 who is using the website, or has registered an account on the website, please contact us as soon as possible with any relevant information. If you are the parent or legal guardian of anyone under that age of 16, and they have registered an account on the website, please contact us for cancellation of their account. Any information provided to streemin for this purpose will only be used to verify that you are the legal guardian of the child in question.
