This policy is for the website streemin.co.uk (alternately referred to as streemin) and its derivatives. This policy governs the terms of use of this website for its users and those who choose to use it. This policy and its terms are governed by UK law and are subject to it. This policy is to be understood and accepted in tandem with the related policies that govern the use of the website, including, but not limited to the streemin privacy policy and the streemin cookie policy.

1. The Website

Streemin.co.uk is a free video hosting and streaming website which enables users to access, view, upload and share videos and video streams from an internet-connected device. Users are required to register for a free account to stream a video and perform advanced interactions with the website. Users are limited in the number of streams they may create, or have active on their account. The website does not retain backups of user content, since the content is being streamed and therefore is not recorded by us or by our service. Advertisements are incorporated into the website. The website is made available for permanent 24/7 access, except in the event of scheduled or unscheduled maintenance or interruptions or in the event of force majeure. We shall not be liable for damage or loss of any kind due to the website being unavailable, including, but not limited to, loss of earnings.

2. Terms of Use

By accessing and/or visiting or using the website in accordance with the terms set out in this policy (whether you are a registered user or unregistered user), either an individual or a single entity ("you" or "your", as applicable), you expressly and unconditionally agree to these terms and all other policies of streemin including, but not limited to, the streemin privacy policy. If you do not agree with any of the terms laid out in this document, or in the other policies of streemin including, but not limited to, the streemin privacy policy, you may not use the website.

3. Our Liability

We are under no legal obligation to monitor content transmitted via or stored on the website. We accept an obligation to enforce the policies governing content on the website in accordance with the Prohibited Content section in the related document, the streemin privacy policy, and to remove any content in violation of that policy, and to pursue legal action if it applies.

4. Your Liability

As a user of the website, you are required to comply fully with the laws and regulations in force. 5. Registration and Access

You must register for a free account in order to supply content or material to the website. You are free to modify the personal data on your account/profile that you supply to the website, or request the removal of any personal data from the website relating to your account. We reserve the right to terminate your use of the website at any time subject to fair prior notice, which may include deleting your account and any related material or content.

6. Prohibited Content

Streemin does not allow the following material, or any content which contains or displays these materials:

- child pornography,
- discriminatory, obscene, defamatory or libelous content,
- illegal or unlawful acts,
- incitement to violence, animal cruelty, animal abuse or drug use,
- any sexually explicit material (including, but not limited to rape, intercourse, fellatio, cunnilingus, masturbation, bestiality, sadistic or masochistic abuse,

pedophilia, necrophilia, any explicit depiction of male or femaile genatalia or pubic areas).

To this end, and to help ensure a safe and compliant community, every stream or video on the website may be reported for review and potential removal from the website. There is a button labelled "report", which is available on the viewing screen for a stream or video. Content which is found to violate these terms will be removed, and appropriate authorities may be notified, as applicable.

Prohibited content, as defined above, may not be added to, nor disseminated through the site in any place, location or capacity. This includes, but is not limited to images used to create a channel or listing on the site, the video or media content presented on the channel or listing, or any images added by a user in any capacity whatsoever. In accordance with this policy, and the other documents governing the use of this site and its derivatives, we may remove, without warning, any content that violates this policy and permanently delete any channel or listing, without warning, which is found to contain this content.

7. Copyright and Likeness Rights

All works whatsoever can only be reproduced with the permission of its creator, the author. A work belongs to its author or rights owner, and he or she alone can consent to any reuse or reproduction. Likewise, individuals have a right to control images, videos and any other content containing their own likeness, and you cannot film people and distribute the video without their consent, or cause an invasion of privacy.
